Resolution to oppose the Camp Grayling increased expansion into Ausable Township Roscommon County

The Township board of Ausable Township, Roscommon County, State of Michigan,

States:

WHEREAS, The Township board of Ausable of Roscommon County, State of Michigan, have expressed concerns with the expansion of Camp Grayling into Ausable Township and Roscommon County.

WHEREAS, Camp Grayling is asking for a twenty-year lease for an additional 162,000 acres from the DNR for Camp Grayling National Guard Training activities significantly expanding the current area used for this purpose within in Ausable Township and Roscommon County.

WHEREAS, The Michigan Department of Natural Resources is seeking public comment on the proposed expansion and has met with justifiable concerns from the public about the proposed expansion and proposed uses.

WHEREAS, the proposed expansion of Camp Grayling and with the increased use will have a negative impact to the rural roads of Ausable Township and Roscommon County and on the state lands within the Township and the County.

WHEREAS, the proposed expansion of Camp Grayling and proposed use will have an adverse impact on the health and general welfare of the citizens of Ausable Township and Roscommon County.

WHEREAS, the proposed expansion of Camp Grayling into Ausable Township and Roscommon County further surrounding and encroaching on even more private property and residences without adequate buffering thus interfering with general quality of life and enjoyment of citizens and visitors is disheartening

WHEREAS, Ausable township is not anti-military the township does not support the expansion of Camp Grayling into Ausable Township or Roscommon County. Therefore, the Township board opposes this expansion.

NOW THEREFORE, IT HEREBY RESOLVED, by the Ausable Township board opposes the proposed expansion of Camp Grayling into Ausable Township and Roscommon County.

BE IT FURTHER RESOLVED, that the board directs the Clerk to forward a copy of this resolution to the Director of the Michigan Department of Natural Resources, The Michigan State Legislature and the State Senators, and to the Governor of Michigan.
