TENTS

A. Definitions:

1. A "Tent" is a portable shelter made of cloth or fabric typically used as a sleeping place or to provide shelter for a celebratory function, supported by one or more poles or other framework and stretched tight by cords or loops attached to pegs driven into the ground.

B. Permissible locations.

- 1. Tents may be erected in the Conservancy zoning districts and in parks or campgrounds designated as trailer coach parks and/or campgrounds licensed by the Michigan Department of Public Health
- 2. Except as provided in subsection 3, no tents shall be erected in R1, Conservancy, or Greenbelt zoning districts which are not designated as a trailer coach park or campground and licensed by the Michigan Department of Public Health. This subsection shall apply to occupied and unoccupied or vacant properties, EXCEPT Running Deere Estates and Kirtland Heights Subdivisions, or any future subdivisions that may be developed within the Township
- 3. Tents are permitted upon any property within the Running Deere Estates and Kirtland Heights Subdivisions, provided a residential structure exists upon the property upon which the tent will be erected, or any future subdivisions that may be developed within the Township subject to the following restrictions:
 - a) A child's tent may be erected on property owned by a parent or grandparent for a period not to exceed seven (7) days.
 - b) Except as provided in subsection c), a tent erected for the purpose of camping on private property is permitted for a period not to exceed seven (7) days.
 - c) If a tent is erected for the purpose of parties, including graduation, celebrations and family gatherings on private property, any tent erected shall be removed after seven (7) days,
 - d) The property owner upon which any tent is erected must allow any occupant or user of the tent access to proper restroom facilities in the dwelling unless an outdoor toilet complying with the applicable regulations imposed by the Michigan Public Health Code has been provided. All temporary or portable outdoor facilities must be removed at the end of the event or when the tent structure is removed.
 - e) At least fourteen (14) days must expire prior to any subsequent erection of any tent on the same property for a new celebration or function.
 - f) Tents shall not be used as accessory structures or for the purpose of storage.
 - An extension of time for use of a tent on specific property may be granted by the Zoning Administrator through a written Permit for an additional seven (7) days, not to exceed three (3) extension in any calendar year, provided no offensive conduct has been generated by the user(s) of the tent during the initial use period. The fees for any permit may be established by the Township Board as it determines from time to time. A Permit may be revoked for violations of the ordinance or any conduct which is disruptive to the public peace, or the use and enjoyment of property owned by adjoining owners.
- C. Violations: A violation of any provision of this section of the Ordinance is determined to be detrimental to the health, safety and general welfare of the residents, property owners and other persons within the township, and is hereby declared to be a nuisance per se. Violations of this section of the Ordinance shall subject both the owner of the property and occupant of any tent to the penalties prescribed in Section 4.21. including a basis for injunctive relief against the violator or landowner to restrain and prohibit the violator or owner from continuing the violation, in addition to any other relief or penalty provided by this ordinance or allowed by law. The township or any

owner or owners of real estate within the township may bring an action to enjoin such alleged violation activity.
